Course Description (including outline and course schedule):

Advanced Writing is a course designed to improve the English writing skills of graduate students of English as a second language. The course is also deigned to introduce students to the format, writing style, and content of empirical research papers, and in particular, the Literature Review. The language of such documents is significantly different from everyday spoken English or from the common language recountered in English literature. A thesis or research papers intended for journal publication are written with more conciseness and directness than other types of writing while following a specific format, such as APA or as designated by the journal. The course is a workshop in conducting and writing a Literature Review for the thesis required for graduation. The purpose of the course is to prepare students to write a Literature Review and to conduct and write a Literature Review while guiding them in the process.
